EXECUTIVE ORDER NO. 0019 SERIES OF 2023

**CREATING THE TECHNICAL WORKING GROUP OF THE
PANGASINAN SALT PRODUCTION PROJECT**

WHEREAS, the Department of Environment and Natural Resources (DENR) consistent with Executive Order No. 192, Series of 1987, is the primary government agency responsible for the conservation, management, development and proper use of the country's environment and natural resources, specifically forest and grazing lands, mineral resources, including those in reservation and watershed areas, and lands of the public domain, as well as the licensing and regulation of all natural resources as may be provided for by law in order to ensure equitable sharing of the benefits derived therefrom for the welfare of the present and future generations of Filipinos;

WHEREAS, sometime in December 2022, the Department of Environment and Natural Resources (DENR) and the Provincial Government of Pangasinan entered and executed a Memorandum of Agreement for the Interim Management of the Foreshore Area for Salt Production and other related activities;

WHEREAS, by virtue of the said Memorandum of Agreement, the Provincial Government of Pangasinan was vested with the Operation and Management of four hundred seventy-three (473) hectares of salt farm located in the municipalities of Bolinao and Bani, Pangasinan;

WHEREAS, to ensure the success of SALT PRODUCTION IN THE PROVINCE, a Technical Working Group must be created to plan and implement the various activities and strategies of said project;

NOW THEREFORE, I, RAMON V. GUICO III, Governor of the Province of Pangasinan, by virtue of the powers vested in me by Law, do hereby create the Technical Working Group of the Pangasinan Salt Production Project and order as follows:
