## EXECUTIVE ORDER NO. 0024, SERIES OF 2023

## AN ORDER CREATING THE JOINT VENTURE SELECTION COMMITTEE OF THE PROVINCE OF PANGASINAN, APPOINTING MEMBERS THEREOF, SPECIFYING ITS DUTIES AND FUNCTIONS, AND FOR OTHER PURPOSES

**WHEREAS**, Provincial Ordinance No. 290-2022 was issued dated December 5, 2022 implementing therein the Provincial Government of Pangasinan Joint Venture Code, to promote better, affordable, and timely services to the community;

**WHEREAS**, the Provincial Government of Pangasinan shall prioritize the public good and general welfare within the framework of sustainable and integrated development, effective constructive engagement, and meaningful people's participation in local governance;

**WHEREAS**, Section 20, Article II of the 1987 Philippine Constitution states that "The State recognizes the indispensable role of the private sector, encourages private enterprise, and provides incentives to needed investments";

**WHEREAS**, Section 3 (l) of the Local Government Code of 1991 provides that "The participation of the private sector in local governance, particularly in the delivery of basic services, shall be encouraged to ensure the viability of local autonomy as an alternative strategy for sustainable development";

**WHEREAS**, there is a need to create a Joint Venture Selection Committee for purposes of selecting a private sector participant (PSP/s) for a specific project.

**NOW THEREFORE, I, RAMON V. GUICO III**, Governor of the Province of Pangasinan, by virtue of the powers vested in me by law, do hereby create the Joint Venture Selection Committee and order as follows:

**Section 2.** The Joint Venture Selection Committee shall be responsible for all aspects of the pre-selection and selection process, including, among others:

- a. the preparation of the feasibility or project study and selection/tender documents:
- b. determination of the minimum designs, performances standards/specifications, economic parameters, and reasonable rate of return or tariff-setting mechanism appropriate to the JV project;
- c. drafting or evaluation of the JV contract;
- d. publication of the invitation to apply for eligibility and submission of proposals or comparative proposals;
- e. defining the eligibility requirements, appropriate for and amount of proposal securities, and schedules of the selection and challenge processes;
- f. pre-qualification of prospective private sector participants (PSPs), bidders, or challengers;
- g. conduct of pre-selection conferences and issuance of supplemental notices;
- h. interpretation of the rules regarding the selection process, conduct of the selection or challenge process;
- i. evaluation of the legal, financial, and technical aspects of the proposals;
- j. resolution of disputes between PSPs and challengers, and defining the appeals mechanisms; and
- k. recommendation for the acceptance of the proposal and/or for the award of the contract.

**Section 3.** This Order shall take effect immediately.
