

**EXECUTIVE ORDER No. 0246-2022**

**AUTHORIZING THE REALIGNMENT OF ACCOUNTS UNDER  
THE GOVERNOR'S OFFICE-ADMINISTRATIVE SERVICES**

**WHEREAS**, the amount left under **Personal Services** accounts 100-1011-01-5-01-01-010 (Salaries and Wages - Regular), 100-1011-01-5-01-03-010-1 (Retirement & Life Insurance Premium - Casual), 100-1011-01-5-01-02-140 (Year End Bonus) and **Maintenance & Other Operating Expenses** accounts 200-1011-01-5-02-11-030 (Consultancy Services), 200-1011-01-5-02-12-990 (Other General Services), are not sufficient to meet the obligations under the said accounts;
