## EXECUTIVE ORDER NO. 0260, SERIES OF 2022

### REORGANIZING THE PROVINCIAL DISASTER RISK REDUCTION AND MANAGEMENT COUNCIL OF THE PROVINCE OF PANGASINAN

**WHEREAS**, Section 11 of Republic Act 10121 otherwise known as the "Philippine Disaster Risk Reduction and management Act of 2010" mandates the organization of the Disaster Risk Reduction and Management Council at the local government level;

**WHEREAS**, the Province of Pangasinan has organized its Provincial Disaster Risk Reduction and Management Council under Executive Order No. 0007-2014 dated February 4, 2014 to strengthen its disaster resilience and governance;

**WHEREAS**, the council was further reconstituted under Executive Order No. 0115-2016 dated August 30, 2019;

**WHEREAS,** now, upon the election of Hon. Ramon V. Guico III, as the new governor of the Province of Pangasinan, as well as upon movements of some functionaries and heads of offices from the National and Provincial government agencies and offices, there is a need to reorganize the composition of the Provincial Disaster Risk Reduction and Management Council;

**WHEREAS**, the reconstituted Provincial machinery will ensure an effective and efficient coordination of various efforts to raise the level of public awareness, consciousness, responsiveness and resiliency in disaster emergency response, rescue and relief operations as well as public safety and rehabilitation;

**NOW THEREFORE, I, RAMON V. GUICO III**, Governor, Province of Pangasinan, by virtue and powers vested upon me by law, regulations and decrees duly promulgated by competent authority, do hereby ordain;

**SECTION 1 – COMPOSITION**. The Provincial Disaster Risk Reduction and Management Council is hereby re-organized with the following composition;

**SECTION 2 – FUNCTIONS.** The newly organized Provincial Disaster Risk Reduction and Management Council shall have the following functions;

- Approve, monitor and evaluate the implementation of the LDRRMPs and annually/regularly review and test the plan consistent with other National and Local planning programs;
- 2. Ensure the integration of Disaster Risk Reduction and Climate Change adaptation into Local Development plans, programs and budget as a strategy in sustainable development and poverty reduction;
- 3. Recommend the implementation of forced or pre-emptive evacuation of local residents, if necessary; and
- 4. Convene the Local Council once every three (3) months or as necessary.

**SECTION 3 – MEETING AND QUORUM.** The meetings of the PDRRMC shall be held once every three months on dates and place to be determined by the body. The chairperson of the council may call for special or emergency meeting as he may necessary.

**SECTION 4 – SECRETARIAT.** The Secretariat shall be headed by the Provincial Disaster Risk Reduction and Management Officer with support personnel from PDRRMC member agencies/offices i.e. Provincial Planning and Development Office (PPDO), Philippine National Police (PNP), Provincial Social Welfare and Development Office (PSWDO), Provincial Engineering Office (PEO), Office of the Provincial agriculturist (OPAG), Provincial Information Office (PIO), Provincial Health Office (PHO) and from the Armed Forces of the Philippines (AFP) during disasters and other major events.

They shall be responsible for the documentation of procedures, meetings, preparation of reports, plans, disaster related activities and other support services that may be required in the discharge of its function.

SECTION 5 - EFFECTIVITY. This order shall take effect immediately.
