DECLARING MUNICIPAL ORDINANCE NO. 05-2021 OF THE SANGGUNIANG BAYAN OF MANAOAG, PANGASINAN, ENTITLED "AN ORDINANCE CREATING THE PLANTILLA POSITION OF TRAFFIC OPERATIONS OFFICER III (POSO) OF LGU MANAOAG, PANGASINAN" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG BAYAN TO ENACT
