PROVINCIAL RESOLUTION NO. 1052-2020

REQUESTING THE METRO PACIFIC TOLLWAYS CORPORATION PARTICULARLY THE NLEX AND SCTEX OPERATION CENTER FOR THE CONDUCT OF AN EASYTRIP RADIO FREQUENCY IDENTIFICATION (RFID) CARAVAN IN THE PROVINCE OF PANGASINAN

WHEREAS, DOTR Department Order No. 2020-012 mandates motorists to install and use Radio Frequency Identification (RFID) in toll expressways to contain the spread of COVID-19;

WHEREAS, toll payments in the expressways will be cashless and contactless and with the above-scheme, motorists now need to acquire RFID stickers or tags;

WHEREAS, Easytrip is the cashless payment service that Metro Pacific Tollways Corporation utilizes for its expressways;

WHEREAS, the Provincial Government of Pangasinan through the Sangguniang Panlalawigan is now requesting the Metro Pacific Tollways Corporation particularly the NLEX and SCTEX Operation Center to conduct an Easytrip RFID Caravan in the Province of Pangasinan to enable majority of Pangasinense-motorists using toll expressways to acquire RFID tags or stickers;

WHEREFORE, on motion of SP Member Jeremy Agerico B. Rosario, duly seconded, it was –
