**WHEREAS**, Supplemental Investment Program No. 9 contains other priority programs, projects and activities that are not included in the approved 2020 Provincial/Annual/Supplemental Investment Program of Pangasinan;

**WHEREAS**, the Supplemental Investment Program No. 9 covers fund augmentation for the personal services, maintenance and other operating expenses and capital outlay of some provincial offices and hospitals and the implementation of various programs and projects of the Province;

**WHEREAS**, there is also a need to realign project from the previously approved Supplement Investment Program No. 1, from: the excess of DOE ER 1-94 fund of *Purchase of Ambulance with Complete Accessories* to: *Purchase of Medical Equipment (Laboratory Services – Water Analysis Lab)*;

**WHEREAS**, this Supplemental Investment Program also includes the programs/projects funded from the Tobacco Excise 2017, CY 2020 Special Education Fund – Supplemental Investment Program No. 1, CY 2021 SEF and details of various infrastructure projects under 20% Development Fund and Non-Office Expenditures of current appropriations;

**WHEREAS**, the programs, projects and activities identified to be funded from the said sources are geared toward the socio-economic development goals and thrusts of the Province;


**WHEREAS**, after careful study of the said Program, this august Body finds it to be in order;
