DECLARING MUNICIPAL ORDINANCE NO. 3, S-2018 OF THE SANGGUNIANG BAYAN OF **BAUTISTA**, "AN PANGASINAN, ENTITLED **ORDINANCE ABOLISHING THE TWO POSITIONS OF ENGINEERING** AIDE, SG-4 UNDER THE MUNICIPAL ENGINEERING **OFFICE AND FISHERY TECHNICIAN, SG-10 UNDER THE** MUNICIPAL AGRICULTURE OFFICE, ALL IN THE MUNICIPALITY OF BAUTISTA, PANGASINAN" AS WITHIN THE POWERS OF CONFERRED THE SANGGUNIANG BAYAN TO ENACT
