#### **RESOLUTION NO. 1095-2020**

DECLARING MUNICIPAL ORDINANCE NO. 2020-07 OF THE SANGGUNIANG BAYAN OF ALCALA, PANGASINAN, ENTITLED "AN ORDINANCE MANDATING THE USE OF FACE SHIELD ALONG WITH FACE MASK WHILE INSIDE THE WORKPLACE, PUBLIC TRANSPORTATION, AND IN PUBLIC PLACES WITHIN THE TERRITORIAL JURISDICTION OF THE MUNICIPALITY OF ALCALA, PANGASINAN DURING THE PERIOD OF COMMUNITY QUARANTINE OR UNTIL LIFTED, AND PROVIDING PENALTIES FOR VIOLATION THEREOF" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG BAYAN TO ENACT

**WHEREAS**, the Sangguniang Bayan of Alcala, Pangasinan submitted its Municipal Ordinance No. 2020-07 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Legal Officer, have conducted initial review and study on said municipal ordinance and found out that the same was enacted pursuant to Section 447 (a) (1) (iii) and (5) (xii) of RA 7160; DILG Memorandum Circular No. 2020-071, Re: Mandatory Wearing of Face Masks or Other Protective Equipment in Public; and the Omnibus Guidelines on the Implementation of Community Quarantine in the Philippines with Amendments as of October 8, 2020; and the Department of Transportation Memorandum Circular No. 2020-04; and Provincial Ordinance No. 242-2020 (An Ordinance Requiring Public Commuters and Drivers, and Employees of Both Government and Private Offices including Commercial Establishments to Wear Face Shield (Along with Face Mask) Within the Territorial Jurisdiction of the Province of Pangasinan During the Period of Community Quarantine or Until Lifted, and Providing Penalties for Violations Thereof);

**RESOLVED**, by the Sangguniang Panlalawigan in session assembled, to declare Municipal Ordinance No. 2020-07 of the Sangguniang Bayan of **Alcala**, Pangasinan, entitled "An Ordinance mandating the use of face shield along with face mask while inside the workplace, public transportation, and in public places within the territorial jurisdiction of the Municipality of Alcala, Pangasinan during the period of community quarantine or until lifted, and providing penalties for violation thereof" as within the conferred powers of the Sangguniang Bayan to enact;
