DECLARING ORDINANCE NO. 2017-04 OF THE SANGGUNIANG BAYAN OF BOLINAO, PANGASINAN, ENTITLED "AN ORDINANCE ENACTING THE 2017 TOURISM CODE OF THE MUNICIPALITY OF BOLINAO, PANGASINAN" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG BAYAN TO ENACT

WHEREAS, the Sangguniang Bayan of Bolinao, Pangasinan submitted its Ordinance No. 2017-04 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Legal Officer, have conducted initial review and study on said ordinance and found out that the same was enacted pursuant to Section 16 of RA 7160;

WHEREAS, subject ordinance shall take effect after the Sangguniang Bayan has complied with the legal requirements set forth in Sections 187 and 188 and 511 (a) of RA 7160;
