RESOLUTION NO. 1103-2021

APPROVING RESOLUTION NO. 11-21-59 OF THE SANGGUNIANG BAYAN OF MABINI, PANGASINAN, ENTITLED “ADOPTING AND APPROVING THE ANNUAL INVESTMENT PROGRAM (AIP) FOR THE BUDGET YEAR 2022 OF THE LGU MABINI, PANGASINAN”

WHEREAS, the Sangguniang Bayan of Mabini, Pangasinan submitted its SB Resolution No. 11-21-59 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No.7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said SB Resolution and found out that the same is in pursuant to Sections 106, 109 and 114 of R.A. 7160;

WHEREAS, the Local Development Council of Mabini, Pangasinan had identified and prioritized programs and projects in their Annual Investment Program for CY 2022. This was endorsed by the Local Development Council to the Sangguniang Bayan on October 7, 2021 thru MDC Resolution No. 6, Series of 2021;

WHEREAS, the Annual Investment Program of the municipality is in accordance with the Budget Operations Manual (BOM) for Local Government Units – 2016 Edition and in pursuance to DILG-NEDA-DBM-DOF Joint Memorandum Circular No. 1 Series of 2007 dated 08 March 2007 and DBM-CCC-DILG JMC No. 2014-dated August 7, 2014, as amended by DBM-CCC-DILG JMC No. 2015-1 – dated July 23, 2015 as to format and content. The AIP of Mabini, Pangasinan was formulated following the prescribed AIP Summary Form and covers a) all the regular budgetary requirements for

the operation of the different municipal offices broken down into PS, MOOE and Capital Outlay, b) the priority development programs/projects of the LGU including those to be funded by the 20% development fund, c) disaster risk reduction programs, projects and activities, d) Local Climate Change Action Plan, e) Peace and Order Plan, f) Local Nutrition Action Plan, g) Gender and Development Plan, h) Culture and Arts Plan, i) Tourism Plan, and j) programs, projects and activities (PPAs) for the Local Council for the Protection of Children, Senior Citizens and Persons with Disabilities and PPAs to combat Acquired Immune Deficiency Syndrome;

WHEREAS, the proposed AIP of Mabini for CY 2022 has a total investment requirement of P202,729,916.41. Funding support for the implementation of this AIP is embodied in their 2022 proposed Annual Budget, which was passed and approved by their Sangguniang Bayan on November 22, 2021 thru Appropriation Ordinance No. 3, Series of 2021 in the amount of P198,336,100.00. The remaining P 4,393,816.41 will be sourced from their unexpended balances from Local Disaster Risk Reduction and Management Fund CY 2017 and 2018;

WHEREAS, this AIP is in accordance with Section 287 of LGC of 1991. Twenty percent (20%) of the LGU's IRA (P190,000,000.00), which is equivalent to P38,000,000.00 is allocated for development projects. These development programs/projects conform to the Joint DBM-DOF-DILG Memorandum Circular No. 1, dated November 4, 2020 (Revised Guidelines on the Appropriation and Utilization of the Twenty Percent (20%) of the Annual Internal Revenue Allotment (IRA) for Development Projects);

WHEREAS, the Disaster Risk Reduction and Management Plan in preparation for and to mitigate the impact of disasters to be funded by the 5% LDRRM Fund (P9,765,400.00, is in conformity to Section 21 of RA 10121. The programs, projects and activities to be funded by 70% of the 5% LDRRM Fund in the amount of P6,835,780.00 and the unexpended balances from their LDRRMF CY 2017 and 2018 in the amount of P 4,393,816.41 were based on NDRRMC-DBM-DILG Joint Memorandum Circular No. 2013-1 dated March 25, 2013 of the Department of Interior and Local Government (Allocation and Utilization of the Local Disaster Risk Reduction and Management Fund). The 2019-2025 LDRRM Plan was reviewed and certified by the Office of the Civil Defense Regional Office I;

WHEREAS, the LGU of Mabini had also identified programs, projects and activities responsive to Climate Change and tagged its corresponding expenditures in their AIP. This is in pursuance to DBM-CCC-DILG Joint Memorandum Circular No. 2015-01 dated July 23, 2015;

WHEREAS, the Gender and Development Programs, Projects and Activities (GAD-PPAs) attached were reviewed by the DILG Provincial Office and were found to be fully compliant in form and in contents with the provisions of the Joint Memo-Circular (DBM, PCW, DILG & NEDA) No. 2016-01 Amendments to JMC 2013-01 or the Guidelines on the Localization of the Magna Carta of Women;
