RESOLUTION NO. 1118-2021

DECLARING MUNICIPAL ORDINANCE NO. 18, S-2021 OF THE SANGGUNIANG BAYAN OF BAYAMBANG, PANGASINAN, ENTITLED “AN ORDINANCE PROHIBITING GENDER-BASED SEXUAL HARASSMENT IN STREETS, PUBLIC SPACES, ONLINE PLATFORMS, WORKPLACES AND EDUCATION OR TRAINING INSTITUTIONS IN THE MUNICIPALITY OF THE BAYAMBANG AND PROVIDING PENALTIES FOR VIOLATION THEREOF” AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT

WHEREAS, the Sangguniang Bayan of Bayambang, Pangasinan submitted its Ordinance No. 18, S-2021 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer have conducted initial review and study on said municipal ordinance and found out that the same was enacted pursuant to Section 17 (a) (iv) of R.A. No. 7160, Republic Act No. 11313 or “Safe Spaces Act”, Republic Act No. 7877 or “Anti- Sexual Harassment Act of 1995” and Republic Act No. 9262 or Anti-Violence Against Women and their Children Act of 2004;

WHEREAS, subject ordinance shall take effect after compliance with the requirement of publication pursuant to Section 511 (a) of RA No. 7160;


