**RESOLUTION NO. 1140-2020**

**DECLARING ORDINANCE NO. 147, S-2020 OF THE SANGGUNIANG BAYAN OF BASISTA, PANGASINAN, ENTITLED "AN ORDINANCE ADOPTING THE OFFICIAL SEAL OR LOGO OF THE MUNICIPALITY OF BASISTA, PANGASINAN, PRESCRIBING THE USE AND IMPOSING PENALTY FOR UNOFFICIAL OR UNAUTHORIZED USE THEREOF" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG BAYAN TO ENACT**

**WHEREAS**, the Sangguniang Bayan of Basista, Pangasinan submitted its Ordinance No. 147, Series of 2020 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Legal Officer, have conducted initial review and study on said ordinance and found out that the same pursuant to Section 16 of RA 7160;

**WHEREAS**, subject ordinance shall take effect after compliance with the requirements of posting and publication pursuant to Sections 59 (c) and 511 (a) of RA 7160;

**WHEREFORE**, in view of the foregoing, on motion of SP Members Nestor D. Reyes and Von Mark R. Mendoza and co-sponsored by SP Members Sheila Marie S. Perez-Galicia and Jerome Vic O. Espino., duly seconded, it was –

**RESOLVED**, by the Sangguniang Panlalawigan in session assembled, to declare Ordinance No. 147, S-2020 of the Sangguniang Bayan of **Basista**, Pangasinan, entitled "An Ordinance adopting the official seal or logo of the Municipality of Basista, Pangasinan, prescribing the use and imposing penalty for unofficial or unauthorized use thereof" as within the conferred powers of the Sangguniang Bayan to enact;
