**APPROVING RESOLUTION NO. 212-11162020 OF THE SANGGUNIANG BAYAN OF POZORRUBIO, PANGASINAN, ENTITLED “APPROVING THE THIRD SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM FOR CY 2020 FUNDED BY EXCESS FROM ESTIMATED INCOME AND REVERSION OF APPROPRIATION OF UNFILLED POSITIONS OF POZORRUBIO, PANGASINAN”**

**WHEREAS**, the Sangguniang Bayan of Pozorrubio, Pangasinan submitted its Resolution No. 212-11162020 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the Local Development Council of Pozorrubio, Pangasinan has formulated and endorsed the municipality’s Third Supplemental Annual Investment Program thru MDC Resolution No. 03, S-2020 dated October 27, 2020 to the Sangguniang Bayan for approval. This was approved by their Sangguniang Bayan on November 16, 2020 through Resolution No. 212-11162020. This is in pursuance to Sections 106, 109 and 114 of RA 7160;

**WHEREAS**, the Third Supplemental Annual Investment Program with an investment requirement amounting to P10,563,376.00 covers fund augmentation for the disaster risk reduction and management programs, personal services and maintenance and other operating expenses and capital outlay of offices of the municipal government;

**WHEREAS**, the Sangguniang Bayan enacted Supplemental Budget No. 3 thru Appropriation Ordinance No. 04-1116-2020 to support the implementation of the Third Supplemental Annual Investment Program of the LGU;


