WHEREAS, the Sangguniang Bayan of Asingan, Pangasinan submitted its Resolution No. 252, Series of 2020 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the Local Development Council of Asingan, Pangasinan has adopted and endorsed the municipality's Supplemental Annual Investment Program No. 6 thru MDC Resolution No. 7, S-2020 dated November 3, 2020 to the Sangguniang Bayan for approval. This was approved by their Sangguniang Bayan on November 9, 2020 through Resolution No. 252, S-2020;

WHEREAS, the Supplemental Annual Investment Program No. 6 with an investment requirement amounting to P300,050.43 covers the LGU counterpart-Early Childhood Care and Development Center and maintenance of Dog Impounding Facility of the municipality;

WHEREAS, the Sangguniang Bayan enacted Supplemental Budget No. 6 thru Appropriation Ordinance No. 7, S-2020 dated November 9, 2020 to support the implementation of the programs/projects embodied in the Supplemental Investment Program No. 6 of Asingan;
