PROVINCIAL ORDINANCE NO. 116-2005

AN ORDINANCE RENAMING THE TOURISM OPERATIONS DIVISION OF THE OFFICE OF THE PROVINCIAL GOVERNOR TO TOURISM OPERATIONS AND PARKS ADMINISTRATION DIVISION, OFFICE OF THE GOVERNOR AND TRANSFERRING SOME POSITIONS FROM THE OFFICE OF THE PUBLIC INFORMATION OFFICER, PROVINCIAL PLANNING AND DEVELOPMENT OFFICE, AND GENERAL SERVICES OFFICE TO THE NEW OFFICE

WHEREAS, Section 76 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, provides that every local government unit shall design and implement its own organizational structure and staffing pattern taking into consideration its service requirement and financial capability, subject to the minimum standard and guidelines prescribed by the Civil Service Commission;

WHEREAS, Section 468 (a) (1) (viii) of the same Code provides that the Sangguniang Panlalawigan has the power to determine the positions and salaries including allowances and other emoluments and benefits of employees of the provincial government;

WHEREAS, there is a need to rename the Tourism Operations Division to Tourism Operations and Parks Administration Division, Office of the Governor, considering that the parks along the Capitol Compound including Maramba Boulevard will be the show window of said Office;

SECTION 2. The corresponding salaries and other benefits of the above-mentioned positions shall be incorporated in Supplemental Budget No. 1 of the General Fund of the Province for CY 2005.
