PROVINCIAL ORDINANCE NO. 117-2005

AN ORDINANCE RECLASSIFYING SOME POSITIONS UNDER THE OFFICE OF THE PROVINCIAL VETERINARIAN AND CONVERSION OF ONE POSITION UNDER THE OFFICE OF THE PROVINCIAL BUDGET OFFICER

WHEREAS, Section 468 (a) (1) (viii) of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, provides that the Sangguniang Panlalawigan has the power to determine the positions and salaries including allowances and other emoluments and benefits of employees of the provincial government;

WHEREAS, the positions of Agricultural Center Chief II, Veterinarian I, and Agricultural Technician I are now vacant in the Office of the Provincial Veterinarian;

WHEREAS, there is a need to convert the position of Computer Programmer I under the Office of the Provincial Budget Officer pursuant to Budget Circular No. 2004-3 dated March 6, 2004;

WHEREAS, there will be no increase in appropriation for salaries, allowances and insurances for the above-mentioned positions;

SECTION 1. The positions of Agricultural Center Chief II, Veterinarian I, and Agricultural Technician I are hereby reclassified as follows:
