DECLARING ORDINANCE NO. 10, S-2019 OF THE SANGGUNIANG BAYAN OF ASINGAN, PANGASINAN. ENTITLED "AN **ORDINANCE PROHIBITING ALL TYPES OF MOTORIZED** VEHICLE WITHOUT **COMPLETE** AND **OPERATIONAL** FIXTURES AND NON-MOTORIZED LIGHTING VEHICLE WITHOUT REFLECTORIZED DEVICES OR STICKERS FROM PLYING AT THE NATIONAL ROAD, PROVINCIAL, MUNICIPAL AND BARANGAY ROADS WITHIN THE TERRITORIAL JURISDICTION OF THE MUNICIPALITY OF ASINGAN. PANGASINAN FROM 6:00 O'CLOCK IN THE EVENING UNTIL 6:00 O'CLOCK THE FOLLOWING MORNING AND PROVIDING PENALTIES FOR VIOLATIONS THEREOF" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG BAYAN TO **ENACT**

WHEREAS, the Sangguniang Bayan of Asingan, Pangasinan submitted its Ordinance No. 10, Series of 2019 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Legal Officer, have conducted initial review and study on said ordinance and found out that the same was enacted pursuant to Section 447 (a) (1) (iii), (2) (vi), (5) (v) of RA 7160;

WHEREAS, subject ordinance shall take effect after the Sangguniang Bayan has complied with the requirements of posting and publication pursuant to Sections 59 (c) and 511 (a) of RA 7160;

> WHEREFORE, in view of the foregoing, on motion of SP Members Noel C. Bince and Salvador S. Perez, Jr. and co-sponsored by SP Members Sheila Marie S. Perez-Galicia, Jerome Vic O. Espino and Jose G. Peralta, Jr., duly seconded, it was –

> **RESOLVED**, by the Sangguniang Panlalawigan in session assembled, to declare Ordinance No. 10, S-2019 of the Sangguniang Bayan of **Asingan**, Pangasinan, entitled "An Ordinance prohibiting all types of motorized vehicle without complete and operational lighting fixtures and non-motorized vehicle without reflectorized devices or stickers from plying at the national road, provincial, municipal and barangay roads within the territorial jurisdiction of the Municipality of Asingan, Pangasinan from 6:00 o'clock in the evening until 6:00 o'clock the following morning and providing penalties for violations thereof" as within the conferred powers of the Sangguniang Bayan to enact;
