PROVINCIAL RESOLUTION NO. 127-2019

URGING THE **COMMISSION** ON **ELECTIONS,** DEPARTMENT OF ENVIRONMENT AND NATURAL RESOURCES, **DEPARTMENT OF** EDUCATION. DEPARTMENT OF PUBLIC WORKS AND HIGHWAYS, PHILIPPINE **NATIONAL** POLICE, **GOVERNMENT** UNITS AND OTHER **CONCERNED AGENCIES** TO **IMMEDIATELY ADDRESS** CONCERNS OF THE PEOPLE OF PANGASINAN ON THE ENVIRONMENTAL AND SAFETY HAZARDS CAUSED BY THE IRRESPONSIBLE ADVERTISING TARPAULINS PRIVATELY OR POLITICALLY PLACED ON TREES. ROADS, BRIDGES, LIGHT POSTS, SCHOOLS AND THE LIKE

WHEREAS, the use of tarpaulins nowadays has become very popular for all types of advertising and promotion, be it in the world of business and politics and other areas;

WHEREAS, the problem, however, goes beyond the massive hanging of tarpaulins on unauthorized places like bridges, light posts, and trees that have to be resolutely removed by the concerned authorities;

WHEREAS, preemptive measures have to be undertaken to address imminent danger that could happen from unauthorized display spots of tarpaulins in order to protect the public health and the environment;

WHEREAS, the Sangguniang Panlalawigan is taking the cudgels for the people and the environment to urge concerned authorities in the enforcement of environmental and other existing laws to address the problem of irresponsible and indiscriminate posting of advertising tarpaulins causing obstruction to the public or even private places;

WHEREAS, the disorderly display of advertising tarpaulins can also be an eyesore to the beauty and landscape of the surroundings and thoroughfares of the Province, hence, the need to designate a common poster area for every locality;

WHEREAS, everyone should take full responsibility for his or her own proper use of advertising tarpaulin by adhering to national and local laws in order not to harm the people and the environment;

WHEREFORE, in view of the foregoing, on motion of SP Member Jeremy Agerico B. Rosario, duly seconded, it was –

RESOLVED, by the Sangguniang Panlalawigan in session assembled to urge, as they are hereby urged, the Commission on Elections, Department of Environment and Natural Resources, Department of Education, Department of Public Works and Highways, Philippine National Police, Local Government Units and other concerned agencies to immediately address the concerns of the People of Pangasinan on the environmental and safety hazards caused by the irresponsible advertising tarpaulins privately or politically placed on trees, roads, bridges, light posts, schools and the like;

RESOLVED FINALLY, to furnish copies of this resolution to the Commission on Elections, Department of Environment and Natural Resources, Department of Education, Department of Public Works and Highways, Philippine National Police, Local Government Units and other concerned agencies, for their information and appropriate action.
