APPROVING RESOLUTION NO. 51, S-2018 OF THE SANGGUNIANG BAYAN OF AGUILAR, PANGASINAN, ENTITLED "APPROVING THE ANNUAL INVESTMENT PLAN OF THE MUNICIPALITY OF AGUILAR CY 2019"

WHEREAS, the Sangguniang Bayan of Aguilar, Pangasinan submitted its Resolution No. 51, Series of 2018 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the same is in consonance to Sections 106, 109, 114 of RA 7160. The Local Development Council of Aguilar, Pangasinan had identified and prioritized programs and projects in their Annual Investment Program for CY 2019. This was endorsed by the Council to the Sangguniang Bayan thru MDC Resolution No. 5, S-2018 dated August 28, 2018 and was favorably acted upon by the Sangguniang Bayan on November 26, 2018 thru SB Resolution No. 51, S-2018;

WHEREAS, the Annual Investment Program of the municipality is in accordance with the Budget Operations Manual (BOM) for Local Government Units, 2016 Edition and in pursuance to DILG-NEDA-DBM-DOF Joint Memorandum Circular (JMC) No. 1, S-2007 dated March 8, 2007 and DBM-CCC-DILG JMC No. 2014-01 dated August 7, 2014, as amended by DBM-CCC-

DILG JMC No. 2015-01 dated July 23, 2015 as to format and content. The AIP of Aguilar, Pangasinan was formulated following the prescribed AIP Summary Form, and covers: a) all the regular budgetary requirements for the operation of the different municipal offices broken down into: Personal Services (PS), Maintenance and Other Operating Expenses (MOOE) and Capital Outlay, b) the priority development programs/projects of the LGU including those to be funded by the 20% development fund, gender and development, Disaster Risk Reduction (DRR) Programs/Projects/Activities, Local Council for the Protection of Children, programs for Senior Citizens and Peace and Order Plan;

WHEREAS, the proposed AIP of Aguilar for CY 2019 has an investment requirement of P139,890,823.60. Funding support for the implementation of which is embodied in their 2019 proposed Annual Budget which was passed and approved by their Sangguniang Bayan on December 3, 2018 through Appropriation Ordinance No. 05, S-2018;

WHEREAS, this AIP is in accordance with Section 287 of RA 7160. Twenty percent (20%) of the LGUs IRA (P132,961,030.00) which is equivalent to P26,592,206.00 is allocated for development projects;

WHEREAS, the development projects proposed to be funded by the 20% development fund were based on the DILG-DBM Joint Memorandum Circular No. 2017-1, dated February 22, 2017 entitled "Updated Guidelines on the Appropriation and Utilization of the 20% of the Annual Internal Revenue Allotment (IRA) for Development Projects";

WHEREAS, the Disaster Risk Reduction and Management Programs, Projects and Activities in preparation for and to mitigate the impact of disasters to be funded by the 5% LDRRM Fund (P6,990,251.50) were based on Section 21 of RA 10121. However, activities for "Other Expenses" in the amount of P58,176.05 must be specified and must be in accordance with and in conformity to NDRMMC, DBM & DILG Joint Memorandum Circular No. 2013-1 dated March 25, 2013 of the Department of the Interior and Local Government. The DRRM Plan shall be submitted by the municipality to the Office of Civil Defense (OCD) for review as per Local Budget Memorandum No. 77 dated May 15, 2018;

WHEREAS, the LGU of Aguilar had also identified programs, projects and activities responsive to Climate Change and tagged its corresponding expenditures in their AIP. This is in pursuance to DBM-CCC-DILG Joint Memorandum Circular No. 2015-01 dated July 23, 2015;
