APPROVING RESOLUTION NO. S-2019 OF 96. THE SANGGUNIANG PANGASINAN, BAYAN OF CALASIAO, **ENTITLED "APPROVING MDRRMC RESOLUTION NO. 02-2019 ENTITLED "A RESOLUTION ADOPTING THE PROPOSED 5% MUNICIPAL DISASTER RISK REDUCTION AND MANAGEMENT** FUND INVESTMENT PLAN (MDRRMFIP) OF THE MUNICIPALITY OF **CALASIAO** FOR CY 2020 AND **RECOMMENDING APPROVAL OF THE SANGGUNIANG BAYAN** AS BASIS FOR ANNUAL INVESTMENT PROGRAMMING OF **MDRRM FUND TO SUPPORT THE DISASTER RISK REDUCTION ACTIVITIES**"

WHEREAS, the Sangguniang Bayan of Calasiao, Pangasinan submitted its Resolution No. 96, Series of 2019 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the Municipal Disaster Risk Reduction Management Council of Calasiao, Pangasinan has prepared the Municipal Disaster Risk Reduction Management Plan for CY 2020. This was endorsed by the Council thru MDRRMC Resolution No. 02-2019 to the Sangguniang Bayan for approval.

WHEREAS, the Sangguniang Bayan approved the Municipal Disaster Risk Reduction Management Plan through Sangguniang Bayan Resolution No. 02-2019 dated October 28, 2019;

WHEREAS, the projects and activities included in the 5% Local Disaster Risk Reduction and Management Fund amounting to P13,932,381.70 conforms with Section 21 of RA 10121and NDRMMC, DBM & DILG Joint Memorandum Circular No. 2013-1 dated March 25, 2013 (Allocation and Utilization of the Local Disaster Risk Reduction and Management Fund);

WHEREAS, however, the LDRRM Plan of the municipality shall still be submitted to the Office of Civil Defense for review as per Local Budget Memorandum No. 77 dated May 15, 2018;

WHEREAS, the LDRRM Plan has already been included in the LGU's Annual Investment Plan (AIP) for CY 2020 which is in pursuance to DBM & DILG Joint Memorandum Circular No. 2013-1 dated March 25, 2013, which provides that "the projects and activities to be charged against the LDRRM Fund shall be incorporated in the LDRRM Plan and integrated in the approved AIP of the LGU";

WHEREFORE, in view of the foregoing, on motion of SP Members Vici M. Ventanilla and Angel M. Baniqued, Jr. and co-sponsored by SP Members Sheila Marie S. Perez-Galicia, Jerome Vic O. Espino and Jose G. Peralta, Jr., duly seconded, it was –

RESOLVED, by the Sangguniang Panlalawigan in session assembled, to approve Resolution No. 96, S-2019 of the Sangguniang Bayan of **Calasiao**, Pangasinan, entitled "Approving MDRRMC Resolution No. 02-2019 entitled "A Resolution adopting the proposed 5% Municipal Disaster Risk Reduction and Management Fund Investment Plan (MDRRMFIP) of the Municipality of Calasiao for CY 2020 and recommending approval of the Sangguniang Bayan as basis for Annual Investment Programming Of MDRRM Fund to support the disaster risk reduction activities";
