DECLARING ORDINANCE NO. 2018-14 OF THE SANGGUNIANG PANLUNGSOD OF ALAMINOS, PANGASINAN, ENTITLED "AN ORDINANCE CREATING NINETEEN (19) POSITIONS UNDER THE EXECUTIVE DEPARTMENT OF THE LOCAL GOVERNMENT UNIT-ALAMINOS CITY; UPGRADING OF ONE (1) POSITION UNDER THE OFFICE OF THE CITY ASSESSOR AND ONE (1) POSITION UNDER THE OFFICE OF THE CITY COOPERATIVE OFFICER AND DOWNGRADING OF ONE (1) POSITION UNDER THE OFFICE OF THE CITY PLANNING AND DEVELOPMENT COORDINATOR" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG PANLUNGSOD TO ENACT

WHEREAS, the Sangguniang Panlungsod of Alaminos, Pangasinan submitted its Ordinance No. 2018-14 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Local Finance Committee, have conducted initial review and study on said ordinance and found out that the same was enacted pursuant to Sections 76 and 458 (a) (1) (viii) of RA 7160;
