#### **RESOLUTION NO. 167-2019**

APPROVING APPROPRIATION ORDINANCE NO. 4, S-2018 OF THE SANGGUNIANG BAYAN OF AGUILAR, PANGASINAN, ENTITLED "AN ORDINANCE REPROGRAMMING THE AMOUNT OF P10,500,000.00 EARLIER ALLOCATED FOR THE PURCHASE OF LOT FOR THE EXPANSION OF PUBLIC MARKET AND P4,505,000.00 FOR THE PURCHASE OF PAYLOADER FROM THE 20% DEVELOPMENT FUND 2018 ALONG WITH THE CORRESPONDING AIP"

**WHEREAS**, the Sangguniang Bayan of Aguilar, Pangasinan submitted its Appropriation Ordinance No. 4, Series of 2018 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Legal Officer, have conducted initial review and study on said appropriation ordinance and found out that the reprogramming emanated from the Local Development Council of Aguilar, Pangasinan through MDC Resolution No. 4, S-2018 and was endorsed to the Sangguniang Bayan for approval on August 28, 2018. This was favorably acted upon by the Sangguniang Bayan on November 26, 2018 through Appropriation Ordinance No. 4, S-2018;

WHEREAS, the funds to be reprogrammed amounting to P10,500,000.00 and P4,505,000.00 are previously allocated for the Purchase of Lot for the Expansion of Public Market and for the Purchase of Payloader, respectively. These are both embodied in the approved 2018 AIP of the LGU funded by 20% development fund;

WHEREAS, the purpose of reprogramming is to fund more pressing development projects of the municipality as mentioned in Paragraph 2 of the MDC Resolution No. 4, S-2018. These new development projects, reflected in the Updated 2018 Annual Investment Program, are within the same expense class and are in conformity with DILG-DBM Joint Memorandum Circular No. 2017-1, dated February 22, 2017 entitled "Updated Guidelines on the Appropriation and Utilization of the 20% of the Annual Internal Revenue Allotment (IRA) for Development Projects";

**WHEREAS**, the new programs and projects shall be integrated in the previously approved CY 2018 Annual Investment Program of the municipality;

**WHEREFORE**, in view of the foregoing, on motion of SP Members Raul P. Sison and Nestor D. Reyes and co-sponsored by SP Members Sheila Marie S. Perez-Galicia, Jerome Vic O. Espino and Arth Bryan C. Celeste, duly seconded, it was –

**RESOLVED**, by the Sangguniang Panlalawigan in session assembled, to approve Appropriation Ordinance No. 4, S-2018 of the Sangguniang Bayan of **Aguilar**, Pangasinan, entitled "An Ordinance reprogramming the amount of P10,500,000.00 earlier allocated for the purchase of lot for the expansion of public market and p4,505,000.00 for the purchase of payloader from the 20% Development Fund 2018 along with the corresponding AIP";
