APPROVING RESOLUTION NO. 268, S-2018 OF THE SANGGUNIANG BAYAN OF BINMALEY, PANGASINAN, ENTITLED "APPROVING THE REVISED SUPPLEMENTAL INVESTMENT PROGRAM NO. 3 FOR CY 2018 OF THE MUNICIPAL GOVERNMENT OF BINMALEY, PANGASINAN"

**WHEREAS**, the Sangguniang Bayan of Binmaley, Pangasinan submitted its Resolution No. 268, Series of 2018 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the Local Development Council of Binmaley, Pangasinan amended their previously approved Supplemental Investment Program No. 3 for CY 2018 due to change in title of one of the projects embodied therein, from Completion of the Evacuation Center and Multi-Purpose Center in Poblacion to Construction of Binmaley Evacuation Center (Phase III);

WHEREAS, this was endorsed by the Local Development Council of Binmaley, Pangasinan to the Sangguniang Bayan for approval on December 20, 2018 thru MDC Resolution No. 8, S-2018. This was favorably acted upon by the Sangguniang Bayan on December 30, 2018 thru SB Resolution No. 268, S-2018. This is in consonance to Sections 106, 109 and 114 of the Local Government Code of 1991;

WHEREAS, funding for the full implementation of the Revised Supplemental Investment Program No. 3 in the amount of P130,000,000.00 is embodied in the proposed Revised Supplemental Budget No. 3 CY 2018 which was approved by the Sangguniang Bayan on December 30, 2018 thru Appropriation Ordinance No. 6, S-2018;

WHEREAS, the municipality should comply with Finding No. 3 of the Local Finance Committee on the LGU's Revised Supplemental Budget No. 3 which states that the utilization of all appropriations for Capital Outlay, shall, as may be applicable, be subject to the authorization of the Sanggunian on the list of projects to be implemented as ruled by the Supreme Court in the case of Hon. Gabriel Luis Quisumbing, et. al. versus Hon. Gwendolyn F. Garcia, et. al., G.R. No. 175527, December 8, 2008;
