APPROVING RESOLUTION NO. 91, S-2019 OF THE SANGGUNIANG BAYAN OF SAN FABIAN, PANGASINAN, ENTITLED "APPROVING THE SUPPLEMENTAL ANNUAL INVESTMENT PLAN (AIP) NO. 7, FOR CY-2019 OF THE LOCAL GOVERNMENT OF SAN FABIAN PANGASINAN IN THE AMOUNT OF P3,387,238.84"

**WHEREAS**, the Sangguniang Bayan of San Fabian, Pangasinan submitted its Resolution No. 91, Series of 2019 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the Municipal Development Council of San Fabian, Pangasinan has prepared the municipality's Supplemental Annual Investment Program (SAIP) No. 7 for CY 2019. This was endorsed by the Council thru MDC Resolution No. 09, S-2019 dated December 2, 2019 to the Sangguniang Bayan for approval. The Sangguniang Bayan approved said endorsement through Sangguniang Bayan Resolution No. 91, S-2019 dated December 4, 2019;

WHEREAS, said Supplemental Annual Investment Program of the municipality, which has a total funding requirement of P3,387,238.84, covers augmentation funds for Personal Services (to include the granting of the One-Time Service Recognition Incentive for FY 2019), MOOE, 5% MDRRM Fund, and other programs of the LGU;
