DECLARING MUNICIPAL ORDINANCE NO. 015-2018 OF THE SANGGUNIANG BAYAN OF MALASIQUI, PANGASINAN, ENTITLED “AN ORDINANCE CREATING THE POSITION OF ADMINISTRATIVE AIDE III IN THE OFFICE OF THE MUNICIPAL BUDGET OFFICER, OFFICE OF THE MPDC, OFFICE OF THE MUNICIPAL ACCOUNTANT AND OFFICE OF THE MUNICIPAL TREASURER; SOCIAL WELFARE AIDE IN THE OFFICE OF THE MSWDO; LOCAL DISASTER RISK AND REDUCTION MANAGEMENT OFFICER II IN THE OFFICE OF THE MDRRMO AND NURSE I AND NURSE III IN THE OFFICE OF THE RURAL HEALTH UNIT I, ALL IN THE MUNICIPALITY OF MALASIQUI” AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG BAYAN TO ENACT

WHEREAS, the Sangguniang Bayan of Malasiqui, Pangasinan submitted its Municipal Ordinance No. 015-2018 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;
