APPROVING RESOLUTION NO. 2019-265 OF THE SANGGUNIANG BAYAN OF BINALONAN, PANGASINAN, ENTITLED “ADOPTING THE SUPPLEMENTAL INVESTMENT PLAN NO. 2019-06 OF THE MUNICIPALITY OF BINALONAN, PANGASINAN”

WHEREAS, the Sangguniang Bayan of Binalonan, Pangasinan submitted its Resolution No. 2019-265 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the Local Development Council of Binalonan, Pangasinan has formulated the municipality’s Supplemental Investment Program No. 2019-06 and endorsed to the Sangguniang Bayan for approval thru MDC Executive Committee Resolution No. 7, S-2019 dated November 28, 2019. This was approved by their Sangguniang Bayan on December 3, 2019 thru Resolution No. 2019-265. This is in pursuance to Sections 106, 109 and 114 of RA 7160;

WHEREAS, the Supplemental Investment Program No. 2019-06 of the municipality with an investment requirement amounting to P1,000,000.00 covers the implementation of the project, construction of slope protection and establishment of marker with landscaping at Sitio Lubas, Barangay Sta. Catalina;

WHEREAS, to support the implementation of the project embodied in the Supplemental Investment Program No. 6 of the municipality, the Sangguniang Bayan of Binalonan, Pangasinan has enacted Supplemental Budget No. 4 through Appropriation Ordinance No. 2019-05 dated December 3, 2019;
