WHEREAS, presented for consideration is the Supplemental Investment Program No. 1 of the Province of Pangasinan as endorsed by the Provincial Development Council thru PDC Execom Resolution No. 01-19;

WHEREAS, Supplemental Investment Program No. 1 contains other priority programs, projects and activities that are not included in the approved 2019 Provincial Annual Investment Program of Pangasinan;

WHEREAS, the Supplemental Investment Program No. 1 shall cover the fund augmentation for the Maintenance and Other Operating Expenses of the Executive and Legislative Services, Public Affairs Fund, Public Affairs Fund – Other Maintenance and Operating Expenses and implementation of Kalinisan Karaban and Kalusugan Karaban;

WHEREAS, the Supplemental Investment Program No. 1 has a total investment requirement of **P28,500,000.00** which shall be sourced from the unappropriated surplus;

WHEREAS, the programs, projects and activities identified to be funded from the said sources are geared toward the socio-economic development goals and thrusts of the Province;

WHEREAS, after careful study of the said Program, this august Body finds it to be in order;


