#### **RESOLUTION NO. 179-2022**

DECLARING ORDINANCE NO. 21-07 OF THE SANGGUNIANG BAYAN OF STA. MARIA, PANGASINAN, ENTITLED "AN ORDINANCE APPROVING AND RATIFYING THE TERMS AND CONDITIONS OF THE APPROVED LOAN WITH THE LAND BANK OF THE PHILIPPINES AND OTHER PERTINENT DOCUMENTS PERTAINING TO THE LOAN ENTERED INTO BY AND BETWEEN THE MUNICIPAL GOVERNMENT OF STA. MARIA, PANGASINAN AND THE LAND BANK OF THE PHILIPPINES" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT

**WHEREAS**, the Sangguniang Bayan of Sta. Maria, Pangasinan submitted its Ordinance No. 21-07 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer, Provincial Planning and Development Coordinator and the Provincial Accountant have conducted initial review and study on said municipal ordinance and found out that the same was enacted pursuant to Sections 22 (a) (5) (c) 296 (a) (b), and 297 of R.A. No. 7160;

**WHEREAS,** the programs and projects to be funded by the loan are included in the Local Development Investment Program (2021-2023) and Supplemental Investment Program No. 3 for CY 2021 of the Municipal Government of Sta. Maria, Pangasinan;

Maria, Pangasinan must pursue the ordinance in line with the provisions of the Local Government Code of 1991 which mandates that every loan application must comply with the requirements of the Department of Finance, the Bureau of Local Government Finance (Circular No. 1-2012), and the Bangko Sentral ng Pilipinas (BSP Circular No. 769, S-2012);

**WHEREFORE**, in view of the foregoing, on motion of SP Members Salvador S. Perez, Jr. and Noel C. Bince and co-sponsored by SP Members Sheila Marie S. Perez-Galicia, Jerome Vic O. Espino and Jeanne Jinky C. Zaplan, duly seconded, it was –

**RESOLVED**, by the Sangguniang Panlalawigan in session assembled, to declare Municipal Ordinance No. 21-07 of the Sangguniang Bayan of Sta. Maria, Pangasinan, entitled "An Ordinance approving and ratifying the terms and conditions of the approved loan with the Land Bank of the Philippines and other pertinent documents pertaining to the loan entered into by and between the Municipal Government of Sta. Maria, Pangasinan and the Land Bank of the Philippines" as within the conferred powers of the Sanggunian to enact;
