#### **RESOLUTION NO. 180-2021**

APPROVING RESOLUTION NO. 2020-174 OF THE SANGGUNIANG BAYAN OF SUAL, PANGASINAN, ENTITLED "APPROVING THE SUPPLEMENTAL INVESTMENT PROGRAM (SIP) CY 2020 OF SUAL, PANGASINAN AMOUNTING TO TWENTY MILLION SIX HUNDRED SIXTY THOUSAND FIVE HUNDRED TWENTY PESOS AND 39/100 (P20,660,520.39)"

WHEREAS, the Sangguniang Bayan of Sual, Pangasinan submitted its Resolution No. 2020-174 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the same is in consonance to Sections 106, 109, 114 of RA 7160. The Local Development Council of Sual, Pangasinan had identified items in their Supplemental Investment Program for CY 2020. This was endorsed to the Sangguniang Bayan for approval on November 11, 2020 through MDC Executive Committee Resolution No. 2, S-2020;

**WHEREAS**, the said Supplemental Investment Program of the municipality covers fund augmentation for the Personal Services and Maintenance and Other Operating Expenses of some municipal offices;

**WHEREAS**, the proposed Supplemental Investment Program has an investment requirement of P20,660,520.39. Funding for the implementation of the same is embodied in their proposed Supplemental Budget No. 08 for CY 2020, which was enacted by their Sangguniang Bayan on December 3, 2020 through Appropriation Ordinance No. 09;
