**PROVINCIAL RESOLUTION NO. 181-2022**

**AUTHORIZING THE PROVINCIAL GOVERNOR, AMADO I. ESPINO III, TO ENTER INTO AND SIGN AN ADDENDUM AGREEMENT WITH HIMEX CORPORATION FOR THE EXTENSION OF AN ADDITIONAL TERM OF UP TO OCTOBER 31, 2022 OF THE MEMORANDUM OF AGREEMENT**

**WHEREAS**, received by the Sangguniang Panlalawigan for appropriate action is a letter of Dr. Anna Ma. Teresa S. de Guzman, Provincial Health Officer II, dated January 26, 2022, requesting for the passage of a resolution authorizing Governor Amado I. Espino III to enter into and sign an Addendum Agreement with Himex Corporation;

**WHEREAS**, a Memorandum of Agreement (MOA) was executed between the Province of Pangasinan and Himex Corporation and notarized on June 28, 2016 for the provision of CT Scan under Public-Private Partnering scheme for the Urdaneta District Hospital;

**WHEREAS**, as per contract, the MOA has expired on June 28, 2021, however, the Province and Himex Corporation acknowledged that Urdaneta District Hospital started the monthly payment on November 17, 2017, as per Billing Invoice dated August 28, 2017, hence the 60<sup>th</sup> monthly payment as per Article 4.3 of the MOA would be on July 28, 2022, including three (3) months payment delay;

**WHEREAS**, there is a need to extend and continue the MOA until full and complete payment is made in order to comply with the payment schedule under Article 4.3 of the MOA;

**WHEREAS**, the extension of the MOA shall be on the same terms and conditions as contained in the MOA, excepting that the expiration of the MOA shall be on October 31, 2022, or for as long as the payment schedule in Article 4.3 of the MOA has been completely satisfied by Urdaneta District Hospital;



**NOW, THEREFORE**, on motion of SP Member Jeremy Agerico B. Rosario, duly seconded, it was –


