PROVINCIAL RESOLUTION NO. 185-2019

AUTHORIZING THE HONORABLE GOVERNOR, AMADO I. ESPINO III, TO PURCHASE FOURTEEN (14) UNITS OF MOTOR VEHICLE FOR USE BY THE PROVINCIAL GOVERNMENT OF PANGASINAN

WHEREAS, the Provincial Government of Pangasinan is in need of motor vehicles to be used for delivery and as service vehicles for health and other social development programs and projects implemented in the Province;

WHEREAS, the Provincial Government of Pangasinan intends to buy fourteen (14) units of vehicles with a total amount of P16,324,000.00 to be charged to Capital Outlay – Purchase of Vehicles Hospitals (8919-6) fund, with the following specifications:
