APPROVING RESOLUTION NO. 100, S-2018 OF THE SANGGUNIANG BAYAN OF DASOL, PANGASINAN, ENTITLED "APPROVING THE SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM (AIP) NO. 2, CY 2018 OF DASOL, PANGASINAN"

WHEREAS, the Sangguniang Bayan of Dasol, Pangasinan submitted its Resolution No. 100, Series of 2018 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the same is in consonance to Sections 106, 109 and 114 of RA 7160. The Local Development Council of Dasol, Pangasinan had identified items in their Supplemental Investment Program No. 2 for CY 2018 with a total investment requirement of P3,591,515.00. This was endorsed to the Sangguniang Bayan for approval on October 26, 2018 thru MDC Executive Committee Resolution No. 2, S-2018 and was favorably acted upon by the Sangguniang Bayan on November 12, 2018 thru SB Resolution No. 100, S-2018 and approved by the Municipal Mayor on November 26, 2018;

WHEREAS, the Supplemental Investment Program No. 2 covers the fund augmentation for the personal services, maintenance and other operating expenses and capital outlay of various municipal offices and the implementation of development programs/projects of the municipality;


