APPROVING RESOLUTION NO. 2018-133 OF THE SANGGUNIANG PANLUNGSOD OF ALAMINOS, PANGASINAN, ENTITLED "CONFIRMING/APPROVING IN TOTO THE PROPOSED ANNUAL INVESTMENT PROGRAM (AIP) CY 2019"

WHEREAS, the Sangguniang Panlungsod of Alaminos, Pangasinan submitted its Resolution No. 2018-133 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the same is in consonance to Sections 106, 109, 114 of RA 7160. The Local Development Council of Alaminos City, Pangasinan had identified and prioritized programs and projects in their Annual Investment Program for CY 2019. This was endorsed by the City Development Council to the Sangguniang Panlungsod on October 2, 2018 thru CDC Resolution No. 03, S-2018 and was favorably acted upon by the Sangguniang Panlungsod on October 8, 2018 thru SP Resolution No. 2018-133;

WHEREAS, the Annual Investment Program of the city is in accordance with the Budget Operations Manual (BOM) for Local Government Units, 2016 Edition and in pursuance to DILG-NEDA-DBM-DOF Joint Memorandum Circular (JMC) No. 1, S-2007 dated March 8, 2007 and DBM-CCC-DILG JMC No. 2014-01 dated August 7, 2014, as amended by DBM-CCC-DILG JMC No.

2015-01 dated July 23, 2015 as to format and content. The AIP of Alaminos City, Pangasinan was formulated following the prescribed AIP Summary Form, and covers: a) all the regular budgetary requirements for the operation of the different city offices broken down into: Personal Services (PS), Maintenance and Other Operating Expenses (MOOE) and Capital Outlay, b) the priority development programs/projects of the LGU including those to be funded by the 20% development fund, c) gender and development, d) Disaster Risk Reduction (DRR) Programs/Projects/Activities, e) Peace and Order Plan, and f) list of programs/projects/activities for the Local Council for the Protection of Children, Senior Citizens and Persons with Disabilities and to combat AIDS;

WHEREAS, the proposed AIP of Alaminos City for CY 2019 has an investment requirement of P638,000,000.00. Funding support for the implementation of which is embodied in their 2019 proposed Annual Budget which was passed and approved by their Sangguniang Panlungsod on November 26, 2018 through Appropriation Ordinance No. 2018-03 and approved by the City Mayor on December 14, 2018;

WHEREAS, this AIP is in accordance with Section 287 of RA 7160. Twenty percent (20%) of the LGUs IRA (P508,995,913.00) which is equivalent to P101,791,183.00 is allocated for development projects. However, details of projects namely: 1) Infrastructure Development Program in support to: Public Order and Safety, Sports Facilities/Activities, Potable Water Supply, Irrigation System, Construction/Rehabilitation of Roads/Bridges/Buildings, Wireless Internet Governance System Project, Others, and 2) Roads/Building Development Projects for Various Barangays, shall be specified and based on Item 3.0 of the DILG-DBM Joint Memorandum Circular No. 2017-1, dated February 22, 2017 entitled "Updated Guidelines on the Appropriation and Utilization of the 20% of the Annual Internal Revenue Allotment (IRA) for Development Projects";

WHEREAS, the LGU of Alaminos City had also identified programs, projects and activities responsive to Climate Change and tagged its corresponding expenditures in their AIP. This is in pursuance to DBM-CCC-DILG Joint Memorandum Circular No. 2015-01 dated July 23, 2015;

WHEREAS, the Gender and Development Programs, Projects and Activities (GAD-PPAs) attached were reviewed by the Department of Interior and Local Government (DILG) Provincial Office, and were found to be fully compliant in form and in contents with the provisions of the DBM, PCW, DILG & NEDA Joint Memorandum Circular No. 2016-01 entitled "Amendments to JMC 2013-01 or the Guidelines on the Localization of Magna Carta of Women";
