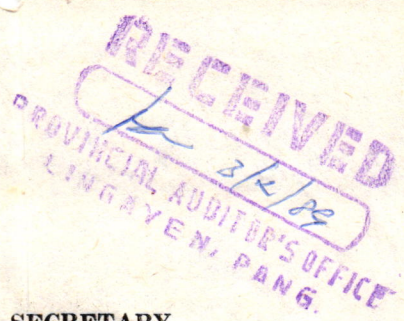
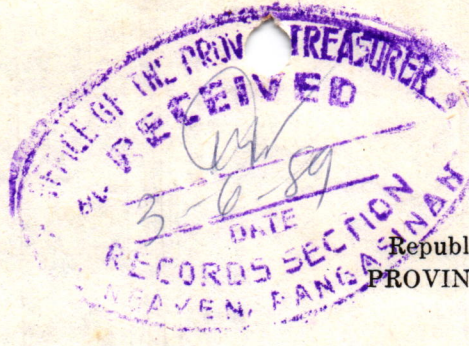

C E R T I F I C A T I O N

TO WHOM IT MAY CONCERN:

THIS IS TO CERTIFY that at the regular session duly constituted of the Sangguniang Panlalawigan, Province of Pangasinan, held on February 6, 1989, at Lingayen, Pangasinan, the following Provincial Ordinance was approved:

PROVINCIAL ORDINANCE NO. 1

AN ORDINANCE DIVIDING BARANGAY POBLACION OF MANAOAG, PANGASINAN INTO THREE (3) NEW, DISTINCT AND INDEPENDENT BARANGAYS TO BE NAMED POBLACION NORTH, POBLACION SUR AND POBLACION WEST

WHEREAS, this Body is in receipt of Resolution No. 75, s-1988 of the Sangguniang Bayan of Manaoag, Pangasinan, requesting this Body to favorably act on the clamor of the residents of Barangay Poblacion, Manaoag to divide Barangay Poblacion and create out of it three (3) distinct, separate and independent barangays to be named Barangays "Poblacion North", "Poblacion Sur" and "Poblacion West" pursuant to Sections 82 and 83 of the New Local Government Code;

WHEREAS, pursuant to the pertinent provisions of the New Local Government Code in the creation of new barangays, all the requirements therein are satisfactorily met;

WHEREAS, the residents and local leaders therein are of the firm belief that the creation would greatly hasten the development of these barangays and human settlement areas;

NOW, THEREFORE, on motion of Board Member Dionisio C. Antiniw, duly seconded and co-authored by all members of the Provincial Board, it was -

RESOLVED by the Sangguniang Panlalawigan in session assembled to divide as it is hereby divided, the present Barangay Poblacion in Manaoag, Pangasinan and create out of it three (3) separate, distinct and independent barangays to be named Barangays "Poblacion North", "Poblacion Sur" and "Poblacion West";

RESOLVED, FURTHER, to request to the COMELEC to schedule the holding of plebiscite in these three (3) newly created Barangays Poblacion North, Poblacion Sur and Poblacion West within 45 days from the approval of this Ordinance;

RESOLVED, FURTHERMORE, that the Provincial Assessor in coordination with other agencies determine the official boundaries of these newly created barangays;

RESOLVED, FINALLY, that copies of this Ordinance be furnished the Provincial Assessor, Provincial Treasurer, Provincial Auditor, Provincial




