**C E R T I F I C A T I O N**

TO WHOM IT MAY CONCERN:

THIS IS TO CERTIFY that at the special session duly constituted of the Sangguniang Panlalawigan, Province of Pangasinan, held on July 22, 1988, at Lingayen, Pangasinan, the following Ordinance was approved:

**PROVINCIAL ORDINANCE NO. 2**

**AN ORDINANCE CREATING SITIO CALOCCAN DUPO INTO A NEW, DISTINCT, SEPARATE AND INDEPENDENT BARANGAY TO BE NAMED "BARANGAY CALOCCAN DUPO", BINMALEY, PANGASINAN**

**EXPLANATORY NOTE**

Caloocan Dupo is an existing sitio of Caloocan Sur in the municipality of Binmaley.

It has at present a population of 1,033 as certified by the Local Government Officer of that municipality and therefore meets the requirements provided for under Section 83 of Batas Pambansa Blg. 337.

The COMELEC registrar also certified the existence of Four Hundred Twenty-Four (424) voters comprising one (1) precinct - Precinct No. 27.

The Municipal Treasurer also issued a certification that the proposed barangay has a good source of income to enable Caloocan Dupo to be a viable barangay from its fisheries and fishponds.

The petition of the barangay council of mother barangay Caloocan Sur in its Resolution No. 1, series of 1988, dated February 18, 1988, and the favorable indorsement of the Sangguniang Bayan of Binmaley are hereto attached and made an integral parts hereof.

In view of the belief that the creation of a new barangay will greatly accelerate the progress and development of the proposed barangay and in the exercise of self-determination and pursuant to the law on Local Autonomy, the creation of Barangay Caloocan Dupo is strongly recommended for approval.

WHEREAS, the 1,033 residents of Sitio Caloocan Dupo of Caloocan Sur, Binmaley, Pangasinan, petitioned the Sangguniang Panlalawigan to create Barangay Caloocan Dupo;

WHEREAS, the creation of said proposed barangay meets all the requirements provided for under Section 83, Article I of Book II of Batas Pambansa Blg. 337;

NOW THEREFORE, on motion of Board Member Roberto N. Ferrer, duly seconded by Board Member Francisco F. Baraan III, it was -




RESOLVED by the Sangguniang Pambalayan in session assembled to create, as a barangay center, **BARANGAY CALUCYAN NPO** in Binalagay, Pangasinan, subject to the approval by a majority of the votes cast in a plebiscite to be called for the purpose in a date to be set by the Commission on Elections as soon as possible, pursuant to Section 83 of Batas Pambansa Blg. 337;


RESOLVED FURTHER to request the COMELEC to schedule the plebiscite in Barangay Npo within forty-five (45) days from the approval of this Ordinance;

RESOLVED FURTHERMORE, that the Provincial Assessor, in coordination with other agencies, determine the official boundaries of the proposed barangay;

RESOLVED FINALLY, that copies of this Ordinance be furnished the Provincial Assessor, Provincial Treasurer, Provincial Auditor, Provincial Engineer, all at Lingayen, Pangasinan; the Department of Local Government, Commission on Elections, Bureau of Lands, Department of Public Works and Highways, PC-IMP and the Department of Education, Culture and Sports (DECS), Manila, for their information and copy.
