APPROVING RESOLUTION NO. 212-2021 OF THE SANGGUNIANG BAYAN OF ROSALES, PANGASINAN, ENTITLED “APPROVING THE SUPPLEMENTAL INVESTMENT PROGRAM NO. 06 CALENDAR YEAR 2021 INVOLVING AN AMOUNT OF ONE MILLION FOUR HUNDRED EIGHTY TWO THOUSAND PESOS (P1,482,000.00) IN THE 2021 GENERAL FUND SOURCED OUT FROM PERSONAL SERVICES FOR THE IMPLEMENTATION OF SERVICE RECOGNITION INCENTIVE IN THE MUNICIPALITY OF ROSALES, PANGASINAN, PURSUANT TO THE MANDATES OF ADMINISTRATIVE ORDER NO. 45, SERIES OF 2021”

WHEREAS, the Local Development Council of Rosales, Pangasinan formulated and endorsed to the Sangguniang Bayan for approval the municipality’s Supplemental Investment Program No. 06 through MDC Resolution No. 1228, S-2021 dated December 28, 2021;
