WHEREAS, the Sangguniang Bayan of San Manuel, Pangasinan submitted its Resolution No. 2021-66 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said SB Resolution and found out that the same is in pursuant to Sections 106, 109 and 114 of R. WHEREAS, the Local Development Council of San Manuel, Pangasinan formulated and endorsed to the Sangguniang Bayan for approval the municipality’s Supplemental Investment Program No. 2021-04 through MDC Resolution No. 05, S-2021 dated December 10, 2021;

WHEREAS, subject Supplemental AIP No. 04 with an investment requirement amounting to P2,237,500.00 covers fund augmentation for personal services and capital outlay of the executive and legislative departments of the municipality;
