#### **RESOLUTION NO. 212-2020**

APPROVING RESOLUTION NO. 80, S-2019 OF THE SANGGUNIANG BAYAN OF AGUILAR, PANGASINAN, ENTITLED "APPROVING THE ANNUAL INVESTMENT PLAN OF THE MUNICIPALITY OF AGUILAR CY 2020"

**WHEREAS**, the Sangguniang Bayan of Aguilar, Pangasinan submitted its Resolution No. 80, Series of 2019 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the same is in consonance to Sections 106, 109, 114 of RA 7160. The Local Development Council of Aguilar, Pangasinan had identified and prioritized programs and projects in their Annual Investment Program for CY 2020. This was endorsed by the Local Development Council to the Sangguniang Bayan on July 25, 2019 thru MDC Resolution No. 6, S-2019 and was favorably acted upon by the Sangguniang Bayan on December 9, 2019 thru SB Resolution No. 80, S-2019;

WHEREAS, the Annual Investment Program of the municipality is in accordance with the Budget Operations Manual (BOM) for Local Government Units, 2016 Edition and in pursuance to DILG-NEDA-DBM-DOF Joint Memorandum Circular (JMC) No. 1, S-2007 dated March 8, 2007 and DBM-CCC-DILG JMC No. 2014-1 dated August 7, 2014 as amended by DBM-CCC-DILG JMC No. 2015-1 dated July 23, 2015 as to format and content. The AIP of Aguilar, Pangasinan was formulated following the prescribed AIP Summary Form and covers: a) all the regular budgetary items for the operation of the different municipal offices broken down into: Personal Services (PS), Maintenance and Other Operating Expenses (MOOE) and Capital Outlay, b) the priority development programs/projects of the LGU including those to be funded by the 20% development fund, c) Disaster Risk Reduction Programs/Projects/Activities, d) Peace and Order Plan, e) Gender and Development Plan, and f) list of programs, projects and activities for the Local Council Protection of Children, Senior Citizens and Persons with Disabilities;

**WHEREAS**, the proposed AIP of Aguilar for CY 2020 has a total investment requirement of P159,020,462.96. Funding support for the implementation of which is embodied in their 2020 proposed Annual Budget passed and approved by their Sangguniang Bayan through Appropriation Ordinance No. 05, S-2019 dated December 16, 2019;

WHEREAS, this AIP is in accordance with Section 287 of RA 7160. Twenty percent (20%) of the LGUs IRA (P149,829,633.00), which is equivalent to P29,965,926.00 is allocated for development projects. The development projects proposed to be funded by the 20% development fund were based on the DILG-DBM Joint Memorandum Circular No. 2017-1, dated February 22, 2017 entitled "Updated Guidelines on the Appropriation and Utilization of the 20% of the Annual Internal Revenue Allotment (IRA) for Development Projects";

WHEREAS, the Disaster Risk Reduction and Management Programs/Projects/Activities in preparation for and to mitigate the impact of disasters to be funded by the 5% LDRRM Fund (P7,844,431.65) is in conformity to Section 21 of RA 10121. The programs/projects/activities to be funded by 70% of the 5% LDDRM Fund in the amount of P5,491,102.15 were based on NDRMMC, DBM & DILG Joint Memorandum Circular No. 2013-1 dated March 25, 2013(Allocation and Utilization of the Local Disaster Risk Reduction and Management Fund of the Department of the Interior and Local Government (Allocation and Utilization of the Local Disaster Risk Reduction and Management Fund). However, the DRRM Plan shall still be submitted by the municipality to the Office of Civil Defense (OCD) for review as per Local Budget Memorandum No. 77 dated May 15, 2018;

**WHEREAS**, the LGU of Aguilar had also identified programs, projects and activities responsive to Climate Change and tagged its corresponding expenditures in their AIP. This is in pursuance to DBM-CCC-DILG Joint Memorandum Circular No. 2015-01 dated July 23, 2015;

WHEREAS, the Gender and Development Programs/Projects/Activities (GAD-PPAs) attached were reviewed by the DILG Provincial Office and were found to be fully compliant in form and in contents with the provisions of the Joint Memorandum Circular (DBM, PCW, DILG & NEDA) No. 2016-01 entitled "Amendments to JMC 2013-01 or the Guidelines on the Localization of Magna Carta of Women";

**WHEREFORE**, in view of the foregoing, on motion of SP Members Nestor D. Reyes and Von Mark R. Mendoza and co-sponsored by SP Members Sheila Marie S. Perez-Galicia, Jerome Vic O. Espino and Jose G. Peralta, Jr., duly seconded, it was –
