**WHEREAS**, the Sangguniang Bayan of Agno, Pangasinan submitted its Resolution No. 125-2021 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No.7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said SB Resolution and found out that the same is in pursuant to Sections 106, 109 and 114 of R. A. 7160;

WHEREAS, the Municipal Development Council of Agno, Pangasinan had identified items in their Supplemental Investment Program No. 9 for CY 2021 and endorsed the same to the Sangguniang Bayan for approval on December 21, 2021 through MDC Executive Committee Resolution No. 09-2021;

WHEREAS, subject Supplemental AIP covers fund augmentation for the Personal Services (granting of Service Recognition Incentive to municipal officials and employees) and Maintenance and Other Operating Expenses of some municipal offices;
