RESOLUTION NO. 238-2022

DECLARING MUNICIPAL ORDINANCE NO. 1, S-2022 OF THE SANGGUNIANG BAYAN OF BINMALEY, PANGASINAN, ENTITLED "AN ORDINANCE EXTENDING THE PERIOD OF RENEWAL OF BUSINESS AND TRICYCLE PERMITS UNTIL FEBRUARY 28, 2022 WITHOUT IMPOSING SURCHARGES OR PENALTIES TO SUPPORT LOCAL BUSINESSES IN THE MUNICIPALITY OF BINMALEY" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG BAYAN TO ENACT

WHEREAS, the Sangguniang Bayan of Binmaley, Pangasinan submitted its Municipal Ordinance No. 1-2022 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer have conducted initial review and study on said municipal ordinance and found out that the same was enacted pursuant to Sections 167 & 192 of R.A. No. 7160 and Republic Act No. 11469, otherwise known as "Bayanihan to Heal as One Act";

WHEREAS, subject ordinance shall take effect after compliance with the requirement of posting pursuant to Section 59 (c) of RA No. 7160;
