RESOLUTION NO. 245-2019

DECLARING THE SUPPLEMENTAL BUDGET NO. 2 FOR CALENDAR YEAR 2018 OF BANI, PANGASINAN INVOLVING A TOTAL APPROPRIATION OF P8,404,000.00 OPERATIVE IN ITS ENTIRETY

WHEREAS, pursuant to R.A. No. 7160, otherwise known as the Local Government Code of 1991, the Sangguniang Panlalawigan of Pangasinan as a legislative body of the Province is empowered to review ordinances authorizing annual or supplemental appropriations of component cities and municipalities in the manner prescribed by law;

WHEREAS, the Sangguniang Bayan of Bani, Pangasinan submitted its Supplemental Budget No. 2 for Calendar Year 2018 involving total appropriations of **P8,404,000.00** which was approved on November 26, 2018 through Appropriation Ordinance No. 04, S-2018 and approved by the Municipal Mayor on December 14, 2018;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Local Finance Committee pursuant to Section 316 of the Local Government Code of 1991, have conducted preliminary review and study on said budget with the finding that the appropriation of additional P1,000.00 each Clothing Allowance for all officials and employees of the municipality shall be subject to Budget Circular No. 2018-1 of the Department of Budget and Management dated March 8, 2018;
