RESOLUTION NO. 25-2021

DECLARING ORDINANCE NO. 16, S-2020 OF THE SANGGUNIANG BAYAN OF SAN FABIAN, PANGASINAN, ENTITLED "AN ORDINANCE REQUIRING PUBLIC COMMUTERS AND DRIVERS, AND EMPLOYEES OF BOTH GOVERNMENT AND PRIVATE OFFICES INCLUDING COMMERCIAL ESTABLISHMENTS TO WEAR FACE SHIELD ALONG WITH FACE MASK WITHIN THE TERRITORIAL JURISDICTION OF THE MUNICIPALITY OF SAN FABIAN, PANGASINAN DURING THE PERIOD OF COMMUNITY QUARANTINE OR UNTIL LIFTED, AND PROVIDING PENALTIES THEREOF" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG BAYAN TO ENACT

WHEREAS, the Sangguniang Bayan of San Fabian, Pangasinan submitted its Ordinance No. 16, Series of 2020 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Legal Officer, have conducted initial review and study on said ordinance and found out that the same was enacted pursuant to Section 447 (a) (1) and (5) (xii) of RA 7160; DILG Memorandum Circular No. 2020-071; Provincial Ordinance No. 242-2020; The Omnibus Guidelines on the Implementation of Community Quarantine in the Philippines, with Amendments as of October 8, 2020; and Memorandum Circular No. 2020-04 of the Department of Transportation;

WHEREAS, however, the Sanggunian shall consider the observations of the Provincial Legal Officer in her opinion dated December 10, 2020;

RESOLVED, by the Sangguniang Panlalawigan in session assembled, to declare Ordinance No. 16, S-2020 of the Sangguniang Bayan of **San Fabian**, Pangasinan, entitled "An Ordinance requiring public commuters and drivers, and employees of both government and private offices including commercial establishments to wear face shield along with face mask within the territorial jurisdiction of the Municipality of San Fabian, Pangasinan during the period of community quarantine or until lifted, and providing penalties thereof" as within the conferred powers of the Sangguniang Bayan to enact;
