APPROVING RESOLUTION NO. 2019-107 OF THE SANGGUNIANG BAYAN OF STA. BARBARA, PANGASINAN, ENTITLED "APPROVING THE SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM OF THE MUNICIPALITY OF STA. BARBARA, PANGASINAN, CALENDAR YEAR 2019, REQUIRING A TOTAL FUNDING OF FIVE MILLION SIX HUNDRED THIRTY- SEVEN THOUSAND EIGHT HUNDRED TWENTY-SIX PESOS (P5,637,826.00)"

WHEREAS, the Sangguniang Bayan of Sta. Barbara, Pangasinan submitted its Resolution No. 2019-107 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the Municipal Development Council of Sta. Barbara, Pangasinan has prepared the municipality's Supplemental Investment Program for CY 2019. This was endorsed by the Council thru MDC Resolution No. 2019-11 dated December 6, 2019 to the Sangguniang Bayan for approval. The Sangguniang Bayan approved said endorsement through Sangguniang Bayan Resolution No. 2019-107 dated December 13, 2019;

WHEREAS, the said Supplemental AIP covers the granting of Collective Negotiation Agreement (CNA) Incentive and Service Recognition Incentive (SRI) for FY 2019 to qualified LGU officials and employees, and fund augmentation for MOOE and CO of some offices of the LGU;


WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order;
