WHEREAS, the Sangguniang Bayan of Urbizondo, Pangasinan submitted its Resolution No. 30-2019 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the new projects under the Gender and Development are aligned with DBM, PCW, DILG & NEDA Joint Memorandum Circular No. 2016-01 entitled "Amendments to JMC 2013-01 or the Guidelines on the Localization of Magna Carta of Women";

WHEREAS, the amendment does not involve changes in the total investment of the AIP 2019 of the municipality of Urbiztondo in the amount of P958,863,251.30;

WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order;


