DECLARING ORDINANCE NO. 2021-033 OF THE SANGGUNIANG BAYAN OF STA. BARBARA, PANGASINAN, ENTITLED "AN ORDINANCE CREATING THE POSITION OF ONE (1) LOCAL LEGISLATIVE STAFF OFFICER III-(SALARY GRADE 16), ONE (1) ADMINISTRATIVE AIDE VI (UTILITY FOREMAN) – (SALARY GRADE 6) AND ADMINISTRATIVE AIDE II (WATCHMAN) – (SALARY GRADE 2) UNDER THE OFFICE OF THE SANGGUNIANG BAYAN, STA. BARBARA, PANGASINAN" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG BAYAN TO ENACT
