DECLARING ORDINANCE NO. 06-2020 OF THE SANGGUNIANG ENTITLED "AN BAYAN OF BURGOS. PANGASINAN. CREATING POSITIONS TWO ORDINANCE THE (2)**ADMINISTRATIVE III, ONE (1) SOCIAL WELFARE AIDE, ONE (1)** NUTRITION OFFICER III AND ONE (1) TAX MAPPING AIDE OF THE MUNICIPALITY OF BURGOS, PANGASINAN, SPECIFYING THEIR POWERS AND DUTIES, APPROPRIATING FUND THEREFOR AND FOR OTHER PURPOSES" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG BAYAN TO ENACT

WHEREAS, the Sangguniang Bayan of Burgos, Pangasinan submitted its Ordinance No. 06-2020 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;
