#### **RESOLUTION NO. 27-2019**

DECLARING ORDINANCE NO. 101, S-2018 OF THE SANGGUNIANG BAYAN OF BASISTA, PANGASINAN, **PROMULGATING ORDINANCE** ENTITLED "AN POLICIES AND MEASURES FOR THE PREVENTION CONTROL OF STI/HIV/AIDS IN BASISTA. **PENALTIES** PANGASINAN, **PROVIDING** VIOLATIONS THEREOF AND CREATING THE BASISTA STI/HIV/AIDS COUNCIL" AS MULTI-SECTORAL THE CONFERRED **POWERS OF** THE WITHIN SANGGUNIANG BAYAN TO ENACT

**WHEREAS**, the Sangguniang Bayan of Basista, Pangasinan submitted its Ordinance No. 101, Series of 2018 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Legal Officer, have conducted initial review and study on said ordinance and found out that the same was enacted pursuant to Sections 17 (b) (iii) and 447 (a) (2) (i) of RA 7160; and RA No. 8504 or An Act Promulgating Policies and Measures for the Prevention and Control of HIV/AIDS in the Philippines;

WHEREAS, subject ordinance shall take effect after the requirements set forth in Sections 59 and 511 (a) of RA 7160 has been complied with by the Sangguniang Bayan;
