APPROVING RESOLUTION NO. 89, S-2019 OF THE SANGGUNIANG BAYAN OF BINMALEY, PANGASINAN, ENTITLED "APPROVING THE 2019 SUPPLEMENTAL INVESTMENT PROGRAM NO. 1 FOR CY 2019 OF THE MUNICIPAL GOVERNMENT OF BINMALEY, PANGASINAN"

**WHEREAS**, the Sangguniang Bayan of Binmaley, Pangasinan submitted its Resolution No. 89, Series of 2019 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the same is in consonance to Sections 106, 109 and 114 of RA 7160. The Local Development Council of Binmaley, Pangasinan had identified items in their Supplemental Investment Program No. 1 for CY 2018. This was endorsed to the Sangguniang Bayan for approval on February 20, 2019 thru MDC Resolution No. 1, S-2019 and was favorably acted upon by the Sangguniang Bayan on February 22, 2019 thru SB Resolution No. 89, S-2019;

WHEREAS, the Supplemental Investment Program No. 1 of the municipality covers fund augmentation for Personal Services, Maintenance and Other Operating Expenses and Capital Outlay of some municipal government offices and the implementation of infrastructure and economic development projects;

WHEREAS, the Supplemental Investment Program No. 1 has an investment requirement of P72,825,131.48. Funding support for the implementation is embodied in Supplemental Budget No. 1, CY 2019 in the amount of P12,825,131.48 which was approved and enacted by their Sangguniang Bayan on February 22, 2019 thru Appropriation Ordinance No. 1, S-2019 and the remaining P64,000,000.00 is proposed for funding by the LGSEF-FA of the national government;
