#### **RESOLUTION NO. 276-2019**

APPROVING RESOLUTION NO. 2018-207 OF THE SANGGUNIANG BAYAN OF BINALONAN, PANGASINAN, ENTITLED "ADOPTING THE ANNUAL INVESTMENT PLAN OF THE MUNICIPALITY OF BINALONAN FOR **CALENDAR YEAR 2019"** 

WHEREAS, the Sangguniang Bayan of Binalonan, Pangasinan submitted its Resolution No. 2018-207 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the Local Development Council of Binalonan, Pangasinan has formulated the municipality's Annual Investment Program for CY 2019 and endorsed thru MDC Resolution No. 2, S-2018 dated July 25, 2018 to the Sangguniang Bayan for approval. This was subsequently approved by their Sangguniang Bayan thru Resolution No. 2018-207 dated November 15, 2018. This is in consonance to Sections 106, 109 and 114 of RA 7160;

WHEREAS, the Annual Investment Program of the municipality is in accordance with the Budget Operations Manual (BOM) for Local Government Units, 2016 Edition and in pursuance to DILG-NEDA-DBM-DOF Joint Memorandum Circular (JMC) No. 1, S-2007 dated March 8, 2007 and DBM-CCC-DILG JMC No. 2014-01 dated August 7, 2014, as amended by DBM-CCC-DILG JMC No. 2015-01 dated July 23, 2015 as to format and content. of Binalonan, Pangasinan was formulated following the prescribed AIP Summary Form categorized into general public, social, economic and other service sectors and covers: a) all the regular budgetary requirements for the operation of the different municipal offices broken down into: Personal Services (PS), Maintenance and Other Operating Expenses (MOOE) and Capital Outlay, b) the priority development programs/projects of the LGU including those to be funded by the 20% development fund, c) Disaster Risk Reduction Management Programs/Projects/Activities of the municipality. It also includes as an integral part the following: 1) Gender and Development Plan, Peace and Order Plan, Local Climate Change Action Plan and 2) list of programs/projects for the Local Council for the Protection of Children, Senior Citizens and Persons with Disabilities;

WHEREAS, the AIP has a total investment requirement amounting to P225,088,708.00. Of this, P200,302,708.00 will be funded from the municipality's proposed 2019 Annual Budget which was passed and approved by their Sangguniang Bayan on November 15, 2018 through Appropriation Ordinance No. 2018-06 and P24,786,000.00 will be funded from the Local Government Support Fund (LGSF), Performance Challenge Fund (PCF) and Assistance to Municipalities Program;

**WHEREAS,** twenty percent (20%) of the municipality's IRA (P130,627,898.00) for CY 2019 amounting to P26,125,580.00 is allocated for development projects. This is in accordance with Section 287 of RA 7160;

WHEREAS, the identified development programs/projects to be funded by the 20% of IRA were based on the DILG-DBM Joint Memorandum Circular No. 2017-1, dated February 22, 2017 entitled "Updated Guidelines on the Appropriation and Utilization of the 20% of the Annual Internal Revenue Allotment (IRA) for Development Projects";

WHEREAS, the programs, projects and activities identified to be funded by the 5% LDRRM Fund of the municipality amounting to P9,966,636.00 conforms with Section 21 of RA 10121 and NDRMMC, DBM & DILG Joint Memorandum Circular No. 2013-1 dated March 25, 2013 (Allocation and Utilization of the Local Disaster Risk Reduction and Management Fund). However, the DRRM Plan shall be submitted by the municipality to the Office of Civil Defense (OCD) for review as provided under Item No. 2.2.12 of the Department of Budget and Management as per Local Budget Memorandum No. 77 dated May 15, 2018;

**WHEREAS**, the LGU has also identified programs, projects and activities responsive to Climate Change Adaptation and tagged its corresponding expenditures in their AIP. This is in pursuance to DBM-CCC-DILG Joint Memorandum Circular No. 2015-01 dated July 23, 2015;
